Please note: In order to complete your child’s FALL registration, a non refundable registration fee of \$100.00 per family is due with this form. (there is no registration fee for graduating students attending June or July camp only)

Once classes are full you may use this form to be placed on our waiting list for a non refundable fee of \$25.00. If requested days become available and you choose to not enroll, you will no longer be kept on the current school year waiting list.

Please register carefully - for all Fall students 30 days Fall tuition for the number of days reserved on this registration form is due upon confirmation of your space. It is refundable with a full 30 days registration cancellation notice prior to July 15, 2021. Thereafter it is non refundable.

If a change to decrease your registered schedule(s) is requested prior to October 1 there will be a change fee of \$100.00 if the change can be accommodated.

All other monthly schedule changes after October 1 must be made with 30 days paid notice once session starts.
